



ASSUMPTION OF RISK; WAIVER; AND LIABILITY RELEASE (the "Agreement")

THIS IS A LIABILITY RELEASE. BY AFFIRMATIVELY AGREEING TO IT, YOU ARE WAIVING LEGAL RIGHTS AND ARE COMPLETELY RELEASING POTENTIAL CLAIMS.

PLEASE READ IT CAREFULLY.

In consideration for the opportunity to attend, participate in or volunteer at the 2026 CrossFit® Divisional Games and/or a community event therein - a **Legends/WheelWod/Prodigies Event** - whether owned, organized, operated, managed, or sponsored by or on behalf of Legends/WheelWod/Prodigies and each of their respective officers, directors, agents, assistants, contractors, volunteers, staff representatives, guests, and employees, coaches, instructors, judges, trainers, Legends/WheelWod/Prodigies Event sponsors, exhibitors and vendors and any venue, location or equipment used in or with any part of a Legends/WheelWod/Prodigies Event with or without supervision and whether such activities take place at or near the venue, traveling to or from the venue or otherwise, and for other food and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, by signing my name and agreeing to this Agreement that I, for myself, my heirs, executors, next of kin, successors in interest, guardians, legal representatives, assigns and administrators, agree as follows:

- 1. Dangerous Activity.** I agree and acknowledge that the Legends/WheelWod/Prodigies Event may involve danger and risk, that the risk of injury from the Legends/WheelWod/Prodigies Event is significant, that the Legends/WheelWod/Prodigies Event can be unpredictable, including, but not limited to, the risk of property damage, serious personal injury, paralysis, rhabdomyolysis, musculoskeletal injuries, cardiovascular injuries, cardiovascular trauma, neurological impairment, heart attack, stroke or even death, falls which can result in serious injury or death, death due to negligence on the part of myself or other people around me, and injury or death due to improper use or failure of equipment. Additional risks include producers of the event, lack of hydration, weather, and or natural conditions. I understand and agree that neither my actions, nor the actions of any other person, can necessarily be controlled and that my safety and health cannot be guaranteed while participating in or observing the Legends/WheelWod/Prodigies Events and related activities or visiting the Venue. I hereby assume all the risks of participating in this event.
- 2. Representation as to Physical Condition.** I have consulted with a qualified physician about my desired participation in the Legends/WheelWod/Prodigies Event and will adhere to the guidelines that my doctor recommends; I am physically able to participate in the Legends/WheelWod/Prodigies Event; I do not suffer from ANY health condition which may be aggravated by participating in the Legends/WheelWod/Prodigies Event, including, but not limited to, heart conditions or high blood pressure, back, neck, or other skeletal, muscular, respiratory or circulatory problems.
- 3. Consent to Medical Treatment.** I consent to receive first aid, medical and/or surgical treatment, or any other services rendered to me in the event of any injury, accident, or illness I incur during my direct or indirect involvement with the Legends/WheelWod/Prodigies Events. I agree and acknowledge that the Released Parties are under no obligation to provide such medical treatment. I ACKNOWLEDGE THAT ANY INJURIES THAT I SUSTAIN MAY BE COMPOUNDED BY NEGLIGENT FIRST AID OR EMERGENCY RESPONSE OF THE RELEASED PARTIES OR OTHER INDIVIDUALS OR MEDICAL EMERGENCY PERSONNEL.

4. **Assumption of Risk.** Understanding, acknowledging and agreeing to the risks and hazards involved with the Legends/WheelWod/Prodigies Event, I freely and voluntarily choose to participate in the Legends/WheelWod/Prodigies Event, travel or, enter, and use the Venue, and I HEREBY VOLUNTARILY AND EXPRESSLY AGREE TO ACCEPT AND ASSUME ALL RISK OF LOSS, DAMAGES, THEFT, INJURY, DEATH THAT MAY OCCUR TO ME OR MY PROPERTY AS A RESULT OF OR INCIDENT TO MY PARTICIPATION IN THE LEGENDS/WHEELWOD/PRODIGIES EVENT, INCLUDING THE RISK I MAY BE INJURED BY THE ACTIONS OF NEGLIGENCE OF THE RELEASED PARTIES, OTHER PARTICIPANTS OR THIRD PARTIES WHILE PARTICIPATION IN THE LEGENDS/WHEELWOD/PRODIGIES EVENT OR VISITING, TRAVELING TO OR FROM THE VENUE. I understand and agree that by agreeing to this Agreement, I am assuming full responsibility for any and all risk of death, serious injury, temporary or permanent disability or property loss and/or damage suffered by me or my property in connection with the Legends/WheelWod/Prodigies Event while visiting, traveling to or using the Venue. I understand and agree that this Agreement will be binding on me, my spouse (or registered domestic partner), my guardians, the executors or administrators of my estate, my heirs, my personal representatives, my assigns, my successors in interest, my children, and any guardian ad litem for said children (collectively, the "Releasers") I accept full and complete responsibility for the safety of myself, any guests, observers, or other individuals who I have invited to the Venue, and property, and I assume the risk of damage, theft, loss or injury caused by others to me, my guests and property.
5. **Liability release and Waiver of Claims.** On behalf of the Releasers and in consideration for being allowed to participate in the Legends/WheelWod/Prodigies Event and/or use of the venue, I HEREBY WAIVE, RELEASE AND FOREVER DISCHARGE ANY AND ALL CLAIMS OR CAUSES OF ACTION, NOW KNOWN, OR HEREAFTER KNOWN IN ANY JURISDICTION THROUGHOUT THE WORLD, AGAINST THE RELEASED PARTIES, INCLUDING, WITHOUT LIMITATION, ANY BODILY INJURY OR LOSS DAMAGE, DESTRUCTION, DELAY, INCONVENIENCE OR OTHER HARM OF WHATEVER NATURE THAT MAY BE DIRECTLY OR INDIRECTLY RELATED TO , ARISING FROM OR SUSTAINED FROM PARTICIPATION IN THE Legends/WheelWod/Prodigies Event AND/OR TRAVEL TO OR FROM OR VISIT TO OR USE OF THE VENUE OR ACTIVITIES RELATED THERETO, NEGLIGENCE FIRST AID OR EMERGENCY RESPONSE OR THE RELEASED PARTIES OR OTHER NEGLIGENCE ACT OR OMISSION OR BREACH OF ANY EXPRESS OR IMPLIED WARRANTY OF ANY RELEASED PARTIES OR OTHERWISE, provided that nothing in this Section 5 shall be deemed to release any Released Party from liability arising from their own willful or intentional injury to me or my property. The claims released hereby include but are not limited to, any claims I may now have or may hereafter acquire resulting from injury, death, or property damage sustained by me or to any property that I may own or may have rented, leased, or borrowed or have in my possession.
6. **Unpredictability of Cause; Personal Responsibility.** I understand that injuries and harm may result from the Legends/WheelWod/Prodigies Event, including working with and around weightlifting, exercise, and fitness equipment and apparatus, climbing ropes, walls, sports, music or entertainment equipment and machinery from a variety of causes, including the acts of omissions of other persons, weather, ice, snow, ocean or water conditions, and other causes not necessarily predictable or within anyone's control. I agree and acknowledge that the Released Parties do not accept any responsibility for injury, loss, or damages suffered by me and that obtaining insurance to cover these risks is my own responsibility. I assume all risk of personal injury, sickness, or death, and damage to or loss of my belongings and property, and any and all other delay, inconvenience, damage, loss or other expenses I may suffer as a result of or in connection with the Legends/WheelWod/Prodigies Events, I agree to be fully responsible for my actions. I assume responsibility for my safety and that of others, including injuries, property damage and harm, to the fullest extent possible and regardless of the acts of omissions of others.
7. **Personal Property.** I agree I am responsible for the security and safety of my own property and any personal effects I use, bring to or leave at the Venue or otherwise related to the Legends/WheelWod/Prodigies Events, and that the Released Parties cannot guarantee the security of my property. Should I leave the property at the Venue or otherwise in the custody of the Released Parties. I do so at my sole and absolute risk. None of the Released Parties shall have any liability to me or anyone else in the event of loss, damage, destruction or use, whether authorized or not, by any person or theft of any such property.

8. **Indemnification.** I AGREE TO INDEMNIFY, DEFEND, AND HOLD HARMLESS THE RELEASED PARTIES, JOINTLY AND SEVERALLY, FROM AND AGAINST ANY AND ALL CLAIMS, ACTIONS, DEMAND, RIGHTS, LOSSES, COSTS, DAMAGES, EXPENSES, SETTLEMENTS, JUDGEMENTS, CAUSES OF ACTION AND LIABILITIES OF ANY KIND WHATSOEVER, WHETHER FORESEEN OR UNFORESEEN, INCLUDING ATTORNEY FEES IN LAW OR IN EQUITY, ARISING OUT OF OR RESULTING FROM ANY CLAIM RELATED TO MY PARTICIPATION IN THE LEGENDS/WHEELWOD/PRODIGIES EVENTS, INCLUDING WITHOUT LIMITATION MY BREACH OF THIS AGREEMENT OR THE LEGENDS/WHEELWOD/PRODIGIES EVENT RULES AND POLICIES. MY ACCEPTANCE OR USE OF ANY PRIZE I MAY ENTITLED TO, INCLUDING ANY TAX LIABILITY IN CONNECTION THEREWITH OR FROM ANY INDIVIDUAL I INVITE TO THE LEGENDS/WHEELWOD/PRODIGIES EVENTS OR VENUE OR MAY OTHER THIRD-PARTY CLAIM RELATED TO THE LEGENDS/WHEELWOD/PRODIGIES EVENTS.
9. **Promise Not To Bring Suit.** I hereby agree and covenant not to, and shall cause the Releasors not to, bring a claim against, sue, demand compensation from or attach the property as assets of the Released Parties or any of them, for any loss or damage resulting or arising from my participation in the Legends/WheelWod/Prodigies Events or my travel to or from or presence at the Venue, and forever release and discharge the Released Parties or any of them from liability under such claims.
10. **Guests.** I assume all risk of damages or injury to any individuals that I invite as guests at the Legends/WheelWod/Prodigies Events or Venues, whether I am present or not, and hereby agree to fully indemnify the released parties against any claims for damages or injury suffered by my invited guests.
11. **Media/ Photography.** I understand that at this event or related activities I may be photographed. I agree to allow my photo, video, or film likeness to be used for any legitimate purpose by producers, sponsors, organizers, and or assignees.
12. **Entire Agreement.** This Agreement fully, completely, and exclusively sets forth my agreement with the Released Parties on the matters set forth herein and may only be amended in a writing executed by both the Released Parties and me.

I UNDERSTAND THAT THE TERMS OF THIS ASSUMPTION OF RISK, WAIVER AND LIABILITY RELEASE MEAN THAT I AM WAVING CERTAIN IMPORTANT RIGHTS THAT I MIGHT OTHERWISE HAVE.

13. **Severability.** In the event that any provision of this Agreement (or portion thereof) is determined by a court of competent jurisdiction to be invalid or otherwise unenforceable, such provision (or part thereof) shall be enforced or, if applicable of such enforcement, shall be deemed to be deleted from this Agreement, while the remainder of this Agreement shall continue in full force and remain in effect according to its stated terms and conditions.
14. A) I UNDERSTAND AND ACKNOWLEDGE THAT BY AFFIRMATIVELY SIGNING AND AGREEING TO THIS AGREEMENT, I AM GIVING UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO RECOVER DAMAGES IN CASE OF INJURY, DEATH, OR PROPERTY LOSS OR DAMAGE. I UNDERSTAND THAT THIS DOCUMENT IS A PROMISE NOT TO SUE AND A RELEASE OF INDEMNIFICATION FOR ALL CLAIMS.

B) I HAVE READ THIS ENTIRE AGREEMENT CAREFULLY, AND FULLY UNDERSTAND ALL OF ITS TERMS AND CONDITIONS; BY AFFIRMATIVELY SIGNING, I AM PROVIDING MY ACKNOWLEDGEMENT AND AGREEMENT THAT I HAVE HAD AN OPPORTUNITY TO CAREFULLY READ THE ENTIRE AGREEMENT AND TO HAVE ANY QUESTIONS ANSWERED TO MY SATISFACTION.

C) IN UNDERSTAND THIS AGREEMENT ENCOMPASSES ALL LEGENDS/WHEELWOD/PRODIGIES EVENT ACTIVITIES INCLUDING BUT NOT LIMITED TO, THE WEEK LEADING UP TO THE EVENT SET UP AND THROUGH BREAKDOWN OF THE EVENT.

I HEREBY REPRESENT, WARRANT AND COVENANT TO THE RELEASED PARTIES THAT EACH OF THE FOLLOWING IS TRUE AND ACCURATE:

- I am at least 18 years of age and I have the right to contract in my own name; or if I am under 18 years of age, my parents or guardian may contract on my behalf.
- I have read the above statements, understand the words and language in this agreement; and have read them.
- I am not pregnant, and I will not consume alcohol or drugs (including, without limitation, any performance enhancing drugs prohibited by Legends/WheelWod/Prodigies) while participating in the Legends/WheelWod/Prodigies Event.
- I have read, understand, and agree to abide by the Legends/WheelWod/Prodigies Events Rules and Policies.
- I am aware of and voluntarily participate despite the potential dangers inherent to the Legends/WheelWod/Prodigies Event.
- I have read this Assumption of Risk; Waiver; and Liability Release and agree to its terms and conditions.
